Missing and Murdered Indigenous Women, Girls and 2SLGBTQQIA+ People left out of Federal Budget 2022

Nothing About Us, Without Us

OTTAWA – The National Families and Survivors Circle (NFSC) is concerned by the absence of specific new funding commitments to families of missing and murdered Indigenous women, girls, and 2SLGBTQQIA+people, and survivors of gender-based violence.

"As more Indigenous women, girls, and 2SLGBTQQIA+ people are disproportionately murdered, go missing, or experience gender-based violence each year, it is crucial for the Federal Government to take action with sustained investments and a whole of government response by implementing the 231 Calls for Justice in alignment with the National Action Plan and the Federal Pathway," said Hilda Anderson-Pyrz, Chair of the NFSC.

The NFSC acknowledges the broader commitments made to Indigenous people in Budget 2022, including an additional \$4.3 billion to Indigenous housing and \$227.6 million to maintain trauma-informed and Indigenous-led mental wellness services, can have a positive impact on those affected by the ongoing genocide of violence against Indigenous women, girls, and 2SLGBTQQIA+ people.

The NFSC reflects on the missed opportunities in Budget 2022 to specifically reference how affected families, communities, and survivors of gender-based violence would benefit. For example, Budget 2022's commitment to help Indigenous communities mitigate the ongoing impacts of COVID-19 could have referenced the "shadow pandemic" of increased gender-based violence during the pandemic.

"Despite the lack of specific commitments in this budget, the NFSC will continue to focus on advocating that all governments produce and fund tangible, needs-based, Indigenous-led solutions on the ground that immediately provide safety and security to Indigenous women, girls, and 2SLGBTQQIA+ people in danger," said Anderson-Pyrz.
